4. The parties acknowledge and agree that _____ shall, as at the date hereof, cease to be liable or responsible to _____ under the Consultant Agreement and that as that same time, the MHRC shall become liable and responsible to _____ under the Consultant Agreement.
5. The _____ acknowledges and agrees that at the request of the MHRC, it shall sign such further documents and do such further things as

- are reasonably required by the MHRC to give full force and effect to this Assignment Agreement and to the Consultant Agreement.
6. All other terms and conditions in the Consulting Agreement shall continue in full force and effect.
